Asotin Co Sheriff Questionnaire Current Sherriff Ken Bancroft elected in 2006

1. Property Tax Liens are attached to properties. Do you think doing so without a court judgment of process of law is good practice?

A Washington State sheriff does not enforce tax liens on property. If law is in place allowing the county treasurer or county auditor to assess such a lien then the applicable county elected official should be able to impose such liens for the purpose stated by law. If checks and balances are not written into the law allowing liens then the people should approach the legislature to enact such checks and balances.

2. From viewing Americas' past experience with FEMA, do you think it is a good idea to have a local Emergency Team in place?

Asotin County has an Emergency Manager working at the county level. He works closely with the Sheriff and County Commissioners in his capacity. So, we do have a local Emergency Team in place already.

3. What is your position on the Sheriff First ACT introduced by Rep. Matt Shea and circulated as initiative I-1061? (This can be seen on thelcteaparty.com web page click on "blog.")

All law enforcement, regardless of the level, needs to keep the other agencies apprised of their involvement within the county. Investigations, by nature, are sensitive in that when too many people are involved the chance for information leaks increase. When this happens the suspect is often allowed to escape arrest if such is warranted. Advising local agencies prior to an arrest and soliciting their participation is a normal operational practice which allows the applicable local law enforcement agency to be aware of the activity within its jurisdiction. Because the Sheriff does not enforce federal law it is best that the federal agencies make the Sheriff aware of the investigation before arrests are made within the county.

4. How would you consider an order to disarm Citizens in Asotin Co. if ordered to by the FED Government?

Only if the Second Amendment of the Constitution was repealed and if the Washington State Constitution and state laws directed such a disarming. The Sheriff is bound to support and defend both the United States Constitution and the Washington State Constitution.

5. Do you think there is merit to STATES RIGHTS?

States rights already exist. In many ways Washington State law is more restrictive than federal law as is the Washington State Constitution. With our form of government we direct our legislative bodies as to how they should vote on issues. If they vote contrary to our wishes then we can vote them out of office to get a person in place that will follow the will of the people.

6. Your reason for wanting this position?

I believe strongly in the Constitution and laws of our country and state. I served in the U. S. Navy for 22 years to preserve our way of life. Asotin Co Sheriff Questionnaire Candidate: John Hilderbrand

- 1. Property Tax Liens are attached to properties. Do you think doing so without a court judgment of process of law is good practice?
- A) It is the practice that is in place at the present time. A lien is a guarantee of payment on non-paid property taxes to the county if the property is sold before the taxes are paid. There must be a court action from a sitting judge before the county can act on the lien, then it becames the duty of the sheriff to enforce the court's order. The sheriff's office is only collecting a debt owed to the county at the time of enforcing the court's order.
- 2. From viewing Americas' past experience with FEMA, do you think it is a good idea to have a local Emergency Team in place?

A)Yes, with that being said, this is where cooperation between all agencies valley wide, would be beneficial. We are already first line responders as FEMA still takes time to mobilize. Here we can provide a vital service to the citizens with inter-agency cooperation until the federal government steps in with additional resources and funding. Through my experience with the fire department, I am well versed in the implementation of the incident command system and unified command system. This is something that is usually lacking from the law enforcement community. The county needs to work hand in hand with all local agencies to be able to provide the best service possible should an event occur.

- 3. What is your position on the Sheriff First ACT introduced by Rep. Matt Shea and circulated as initiative I-1061? (This can be seen on thelcteaparty.com web page click on BLOG.)
- A) It would be well received from my position. This would open the lines of communication between the federal government and the local sheriff's department. It would be a good idea to have the outside agencies notify the sheriff's office of their presence and intentions. I believe we need to have more cooperation between local, county, state and federal agencies

to accomplish our goals of protecting the people of Asotin County and the rest of the nation.

4. How would you consider an order to disarm Citizens in Asotin Co. if ordered to by the FED Government?

A) I do not feel this will ever happen as the Constitution is clear on the right to bear arms. Should such and order be given by the federal government, it would be dismissed as an illegal order unless the constitution is ammended.

5. Do you think there is merit to STATES RIGHTS?

I want to see Asotin County stay safe where other people can work, raise families and recreate.

7. Do you think the State of WASH or Asotin Co, should harbor Illegal immigrants?

- A) No. There are legal ways to gain entry into the U.S. as well as Washington and Asotin County. The people that enter illegally make it harder for the people to enter the county legally. Asotin Prosecuting Atty. Questionnaire Current Prosecutor Benjamin Nichols

1. Property Tax Liens are attached to properties. Do you think doing so without a court judgment of process of law is good practice?

As Prosecuting Attorney for Asotin County I have been involved in property tax lien actions. I believe that the current system used by our county is appropriate and allows due process to all concerned. Any effort to change the system and "short-cut" the property owner's rights would have to be watched closely.

2. From viewing America's past experience with FEMA, do you think it is a good idea to have a local Emergency Team in place?

I am a great believer in local control and local solutions for our problems. I know that Asotin County has many people and agencies that are regularly called upon in times of emergency. I support them and would be sorely disappointed to lose these resources in favor of state or federal programs without local input.

3. What is your position on the Sheriff First ACT introduced by Rep. Matt Shea and circulated as initiative I-1061? (This can be seen on thelcteaparty.com web page click on "Blog.")

I have carefully reviewed the Sheriff First Act proposed by Representative Shea. I am afraid that, while I can see his concerns I am not certain that this is the solution.

4. How would you consider an order to disarm Citizens in Asotin Co. if ordered to by the FED Government?

As Prosecuting Attorney for Asotin County I am charged with enforcing state and local law. I do not have the authority (nor the desire) to enforce federal law. Should an order issue from the federal government to disarm citizens, without some state or local law requiring the same, I would not be called upon to enforce it.

5. Do you think there is merit to state's rights?

In my mind, the genius of our Constitutional form of government lies in its ability to separate power and balance competing interests. Just as our

system of checks and balances between the three branches of the federal government is absolutely necessary to maintain our country so is the recognition that the States and the individual citizens have rights and powers that cannot be assumed by the central government.

6. Your reason for wanting this position?

I have been honored to serve the residents of Asotin County for the past 16-years, first in the capacity of Deputy Prosecutor and then as Prosecuting Attorney. I have 17-years of courtroom experience and one of the highest conviction rates in the State of Washington. I have successfully prosecuted cases from high profile murder cases to oddly obscure cases.

I have worked diligently to hire and retain accomplished and professional support staff for the Asotin County Prosecutor'€Â™s Office. I have sought and obtained grant funding and state funding to improve the quality of service to Asotin County with no additional cost to the residents. The Asotin County Prosecutor'™s Office is open to the public and as long as I remain in office, the citizens of Asotin County have had and will continue to have direct access to their prosecutor.

I have a strong working relationship with local and state law enforcement agencies. I am endorsed by law enforcement, prosecuting attorneys, defense attorneys and civil practice attorneys in the area and across the state.

I live in Asotin County with my family and I am dedicated to the protection of our community. I do not take charging decisions lightly and always consider the balance of what is fair, ethical and financially feasible to the citizens, the victims and the defendants.

I would be honored to continue serving the residents of Asotin County.

7. Do you think the State of WASH or Asotin Co, should harbor Illegal immigrants?

I believe that the federal government should be responsible for setting and enforcing immigration policies and laws. When someone breaks the law in Asotin County it is my job to prosecute them without regard to their immigration status. If this means sending criminals to prison, deporting them, or both, that is what I have always done and will continue to do as long as I hold the job.

8. Under the Constitution, the separation of Powers is very clear. Why is the Commerce Clause important in States Sovereignty?

I am aware of past excesses committed in the name of the federal government's power to create law under the authority of the Commerce Clause. I realize that the federal government has a duty and a place in the regulation of interstate commerce, but this should not be used as device to push the States or the individuals out of their respective roles in the field.

Asotin Prosecuting Atty. Questionnaire

Candidate: Richard Laws

1. Property Tax Liens are attached to properties. Do you think doing so without a court judgment of process of law is good practice?

A lien is not a judgment and doesn't serve to take property from anyone; it's a notice of claim that serves to tell the outside world that the lienholder claims a legal or financial interest in something. Executing on the lien, on the other hand, requires due process, which is at the very least notice and an opportunity to be heard. But the lien itself is a protection not only for the lienholder, but for prospective third party buyers who could otherwise wind up paying for something without knowing there's an outstanding debt attached.

2. From viewing Americas' past experience with FEMA, do you think it is a good idea to have a local Emergency Team in place?

I think a comprehensive disaster response plan, designed to get available city, county, and state resources into place quickly, is vital for the safety of our county's residents. Whether that response plan should include a designated emergency team, and how such a team would be organized and directed, are questions I will defer to the experts, the men and women who put their lives on the line to protect and rescue our residents.

3. What is your position on the Sheriff First ACT introduced by Rep. Matt Shea and circulated as initiative I-1061? (This can be seen on thelcteaparty.com web page click on blog.)

I have concerns about this initiative. I understand there is a specific terrorism exception, but I also think this could have the unintended consequence of hampering federal law enforcement's ability to investigate corruption, illegal immigration, human trafficking, organized crime, and drug

smuggling. I would also need to know how this would impact local sheriff's offices in terms of paperwork and procedural hurdles. I think I understand the intent of the initiative, but if it takes away from county sheriffs' abilities to perform their job functions while simultaneously making it more difficult for federal authorities to investigate crime, I don't think I could support it.

4. How would you consider an order to disarm Citizens in Asotin Co. if ordered to by the FED Government?

I would consider that an illegal order contravening the Second Amendment. I would join any concerted effort of county prosecutors to resist the order, and I would urge our State Attorney General to take immediate action in a federal court to have the order set aside.

5. Do you think there is merit to States Rights?

The Tenth Amendment to the US Constitution guarantees that the powers not granted to the federal government are reserved to the state. That's one of the founding tenets of our federalist system of limited government, so it's not my opinion, it's an unalterable fact: the federal government should do its thing and leave the states to do theirs.

Our state government must be constantly diligent that the federal government does not infringe on the states' sovereignty. Federal funds to the states come with strings attached, and we must carefully scrutinize the consequences of accepting those funds, even if it means saying "no thank you" when the price is a diminishment of our authority.

6. Your reason for wanting this position?

I am running to restore competence, professionalism, and responsibility to the prosecutor's office. I am disheartened by the lack of demonstrated leadership and poor management of the resources in the prosecutor's office. This has been the case for far too long. The current prosecutor allows frivolous cases to advance to trial, which is poor stewardship of taxpayer money, and unfair to local constituents who must alter their schedules to sit on these farcical trials.

I am passionate about the Constitution and firmly believe that the rights enumerated are not discretionary. I have seen too many instances where our prosecutor and his deputies have casually disregarded the rights of defendants and citizens alike. This attitude is unacceptable and in violation of his oath as an attorney and as an elected prosecutor. I will not make this mistake, and neither will my staff.

I want to make the prosecutor's office work for the people, to ensure our safety and security, not waste money.

7. Do you think the State of WASH or Asotin Co, should harbor Illegal immigrants?

Absolutely not. If I am elected, illegal immigrants arrested or otherwise discovered within Asotin County will be held to account for any crimes they may have committed in our jurisdiction, then turned over to federal immigration authorities.

8. Under the Constitution, the separation of Powers is very clear. Why is the Commerce Clause important in States Sovereignty?

Congress' enumerated power over the regulation of interstate commerce granted by Article I, section 8 of the US Constitution has been the engine that drives much federal legislation. Over time, that power has been held to give Congress very broad authority to enact laws when the subject matter touches even tangentially upon interstate commerce. And sometimes federal legislation comes into conflict with the laws a state may desire to put in place within its own borders. When that happens, the Supremacy Clause in Article VI says that federal laws trump those of a state.

There are some government regulations that are necessary to maintain our infrastructure, ensure uniform safety requirements in the workplace, and the manufacturing and distribution of products. If those requirements interfere with interstate commerce, the individual state governments may bring lawsuits to change the impact of the federal law.

Can the government set reasonable conditions on how you spend the money it gives you? Yes, whether you're an individual or a county office or a state government. States and localities have to abide by federal rule when accepting federal money. That is a decision that needs to be made anytime we take money from anyone – what strings are attached? Not all money is worth the cost.

Personally, I am not willing to give up my right to privacy, to bear arms, to free speech or any other fundamental right in order to get a free ride from the federal government. I think it is better to turn down a handout than risk losing even a small portion of my constitutionally protected freedoms.
